Dialect use as interaction strategy

A sociolinguistic study of contextualization, speech perception, and language attitudes in Austria

This study investigates how and by what means speakers of Austrian German use Austrian dialect for rhetorical purposes in interaction. Specifically, it traces the processes and mechanisms underlying conversational 'contextualization' by which speakers strategically index social meanings attaching to dialect style, making them relevant to utterance interpretation. Along with discourse analysis, methodologies from the study of dialect perception and language attitudes are also integrated, in an innovative combination of analytic instruments. This study finds substantial grounds for the claim that participants shift from standard (the 'expected' variety) into dialect for strategic, rhetorical purposes, indexing social stereotypes that the two experiments have shown will be activated by the use of dialectal features.

And All Women Mere Players?

Performance and Identity in Dorothy Richardson, Jean Rhys and Radclyffe Hall

Dorothy Richardson, Jean Rhys and Radclyffe Hall have long been considered minor figures within the larger context of Modernism. This book offers a close reading of these authors' major fictional works. The focus lies on the female heroines of the texts and their sense of identity. Drawing on the theoretical works of Foucault, Butler and de Certeau, Kerstin Fest shows how identity can be perceived as performance. Although in relatively powerless positions, the women in Richardson's, Rhys's and Hall's oeuvres show a surprising degree of agency in carving out their roles to play. The results are highly individual and flexible versions of femininity that refuse to conform to a single mould.

A study of how religious conflict, at one particular time and in one particular culture, manifested itself in biographical literature. It analyzes the connections between English religious biographies of the Reformation and the Counter-Reformation as well as between these and their late medieval counterparts (saints' legends). The book uses approaches from imagology, cultural studies, new historicism, religion and literature, and law and literature.
